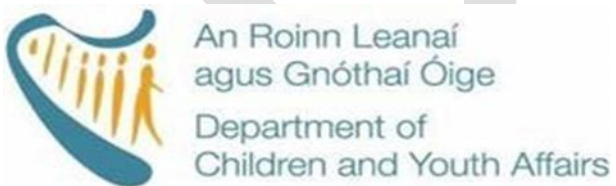

Introduction

The purpose of this document is to provide potential applicants with important information in advance of the opening of applications for Early Years and School Age Capital grants in 2018.

Please note, detailed application guidelines will be made available by DCYA/Pobal in January 2018. This document is not the application guidelines and is intended as preparation material only.

1. Proposed Capital Timeline

2. Application process

This will be an online application process. Applicants will access the online application form via the PIP system. Early Years and School Age Childcare will access and use the same application form. The anticipated "go live date" for applications is February 2018. The application window will close in March 2018.

DCYA Reference numbers and process for new facilities or new service providers for Early Years and or School Age Childcare

To apply for funding under any of the strands, all applicants must have a valid DCYA reference number. The DCYA reference number under which an application is made must be that of the facility (address) at which the grant monies are to be spent and reported.

If you intend to move or open a facility at a different address you must obtain a new DCYA reference number before the opening of capital applications. Details on how to do so are available from your local City /County Childcare Committee (CCC).

3. Planning permission:

If the application is successful, the grant agreement will not be issued without full planning permission being granted, where relevant. This is to ensure that the applicant will be able to carry out the works and report expenditure by 30th November 2018.

Where the planning permission process has commenced, but not been completed, the expected decision date must be provided in the application. Where the planning permission process is completed, a planning permission number must be provided. If no planning permission is required you must state why it is not required.

Applicants must confirm they have a certificate of planning permission for the facility that is the subject of the capital grant.

Applicants should note that if the project applied for will change their current planning situation, (e.g. change of use or increase numbers) they will be required to confirm if they have sought appropriate advice and confirm if new planning permission is required or not.

4. Overview of the Capital 2018 programme

The Early Years and School Age Childcare Capital 2018 programme will be delivered in five strands, as follows:
